Minutes May 6, 2024

- Meeting The regular meeting of the Chateaugay Town Board on 05/6/2024 was called to order by Supervisor Donald Bilow at 6:30 P.M.
- Members Present Supervisor Donald Bilow, Councilman William Trombly, Councilman Kirby Selkirk, Councilman Jim Harrigan, Town Clerk Phyllis LeMay and Highway Superintendent Roger LaBombard. Councilman Scott Cowan was absent.
- Visitors No Visitors
- Minutes A motion was made by Kirby Selkirk and seconded by Jim Harrigan to adopt the minutes of the April 15, 2024, board meeting. All in favor, motion carried.
- Capital Projects Supervisor Bilow reported that he spoke with John Carr from Blue Mountain Engineering to get an update as to when the bids for the bowling alley project would go out. Supervisor reported that DASNY will respond within forty five days regarding our bowling alley application.
- Cemetery There was a legal notice in the Malone Telegram requesting bids for the mowing of the Smith Green cemetery. The town received one (1) bid from JRL Contracting in the amount of \$2,450.00. A motion was made by Bill Trombly and seconded by Kirby Selkirk to approve the bid from JRL Contracting in the amount of \$2,450.00, all in favor, motion carried.
- Rec Park There was a legal notice in the Malone Telegram requesting bids for the use of running the rec park store. The town received one (1) bid from Callie Durant in the amount of \$130.00. A motion was made by Kirby Selkirk and seconded by Jim Harrigan to approve the bid from Callie Durant in the amount of \$130.00, all in favor, motion carried.
- Resolution #27 Supervisor Bilow presented a resolution from Earl Development LLC to ask the town's support in approving and endorsing Earl Development LLC in its application to NYS Homes and Community Renewal for funding under the New York Main Street program. A motion was made by Bill Trombly and seconded by Jim Harrigan to approve the resolution. A roll call vote was taken with the following results: William Trombly – Aye, Scott Cowan – Absent, Jim Harrigan – Aye, Kirby Selkirk – Aye, and Supervisor Donald Bilow, Aye. Motion carried.

Broadband Supervisor Bilow has been in contact with Dave Wolf regarding broadband, supervisor identified all areas that are not covered and he hopes to get the entire town covered.

Reports Roger LaBombard reported the following:

- Roger requested permission for the highway superintendent and the deputy highway superintendent to go to the superintendent of highway school in Cornell on June 3 through June 5. A motion was made by Jim Harrigan and seconded by Kirby Selkirk to approve attending the school, all in favor, motion carried.
- The town received the check from the insurance company for the salt and sand building cover.
- The highway employees have been grading roads and are still sweeping.
- Roger will take down the posts on the Simms Road.

Bills A motion was made by Kirby Selkirk and seconded by Jim Harrigan to pay the bills. Motion carried, all in favor.

Adjournment A Motion was made by Jim Harrigan and seconded by Kirby Selkirk to adjourn the meeting. Motion carried, all in favor.


