RESOLUTION TOWN OF CHATEAUGAY TOWN BOARD A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT FOR FISCAL YEAR 2026

WHEREAS, according to New York State's Property Tax Cap legislation, if a town government decides to adopt a budget with a property tax levy that exceeds the level set by the State, the town government must pass a local law to override that cap, and;

WHEREAS, adopting said local law is not predictive of the final tax levy but will provide the Town Board flexibility to exceed the Property Tax Cap if it is deemed necessary, and to ensure that any State recalculation of the applicable limit will not make the Town inadvertently out of compliance, and;

WHEREAS, a public hearing was held before the Town Board on September 22, 2025, to hear all persons interested in proposed Local Law

NOW THEREFORE, BE IT RESOLVED, that "A Local Law to Override the Tax Levy Limit for Fiscal Year 2026" is hereby adopted pursuant to subdivision 5 of General Municipal Law Section 3-C, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the Town Board; and be it further

RESOLVED that the Town Clerk shall publish in *The Malone Telegram* a notice of adoption containing a synopsis of said local law and shall within twenty days file one certified copy in the Office of the County Clerk, and one copy with the Secretary of State.

On a motion by Member Kirby Selkirk seconded by Member William Trombly the foregoing resolution was adopted on a vote of 3 Ayes, 0 Nays.
