- Meeting** The regular meeting of the Chateaugay Town Board was called to order at 6:30 P.M. on December 20, 2021, at the Chateaugay Town Hall by Supervisor Donald Bilow. All town officials and guests were required to sanitize their hands and wear a mask if they had not been vaccinated.
- Members Present** Supervisor Donald Bilow, Councilman William Trombly, Councilwoman Darby Monette, Councilman Kirby Selkirk, Councilman Scott Cowan, Town Clerk Phyllis LeMay, and Highway Superintendent Roger LaBombard.
- Visitors:** Pat McGuire from Sid G. Spear Insurance.
- Minutes** A motion was made by William Trombly and seconded by Darby Monette to adopt the minutes of the November 22, 2021 and December 2, 2021 board meetings. All in favor, motion carried.
- Insurance** Pat McGuire from Sid G. Spear insurance came before the Board to review the Town of Chateaugay's 2022 insurance. After reviewing the insurance, a motion was made by Kirby Selkirk and seconded by Scott Cowan to approve the town's insurance for 2022. All in favor, motion carried.
- Solar** There was nothing to report on solar.
- Theater** Supervisor Donald Bilow reported that the Gibson Bros. would be here on January 28, 2022.
- Art Society** Supervisor Donald Bilow reported that the Theater Foothills Arts Society will be holding a Kevin Burks performance on March 30, 2022.

- Reports** Roger LaBombard reported that the town survived the windstorm with mostly tree limbs on the roads.

Roger would like to put the bids out for a new plow truck to be opened on 02/14/2022. A motion was made by William Trombly and seconded by Scott Cowan to put the truck out for bid. All in favor, motion carried.
